Company may require Applicant to provide Project site specific details, customer information, scope of work, contract terms, and other information prior to the commencement of a Project.
3. Applicant shall furnish true and correct insurance, liability, and Project information to Company at all times upon request of the Company.
4. Applicant shall indemnify and hold Company harmless from any and all liability associated with or arising out of Project work that is not the direct result of the Company's negligence.
5. Applicant acknowledges that Company may rescind certification of the Applicant at any time. Upon receipt of notice of termination of certification, Applicant shall not be permitted to contract for Projects or install Company products. Applicant shall be permitted to complete any Projects commenced prior to the date of notice of termination.
